I. ROLES AND RESPONSIBILITIES:

To look after the functions relating to MIS(Management Information) viz. monitor & review the MI activities to ensure proper integration of data and flow of information through the system

To Interact with Chairman and Managing Director on the issues relating to Technology implementation. Presenting the IT related matters before the Various Committees, Board of Directors, Top executives of Excise Department and Ministries

To Build & Manage the IT team in an effective manner and responsible for Complete IT projects to be implemented in co-ordination with Excise department as per the project plan approved.

To ensure that the latest forward looking technology is adopted at KSBCL / Excise Department of Karnataka govt. with a maximum return on investment

To enable KSBCL / Excise Department of Karnataka govt. with robust architecture, highest level of security, high availability network and ease of use functions for all stake holders.

II. CONSOLIDATED EMOLUMENTS AND PERKS

III. AGE LIMIT
