**GENERAL TERMS AND CONDITIONS**

Name of Tender : "Supply of Computer Consumables – Cartridges for EPSON DLQ 3500 printers (compatible / equivalent to Epson Cartridge – Minimum length of 16 meters) to KSBCL" on Annual Rate Contract basis

1. The price should be quoted in the prescribed format as per Annexure-I of the tender document. The price quoted should be inclusive of packing, transportation charges & GST. The GST should be mentioned separately on total basic price. The price quoted should be valid for a period of one year from the date of offer.
2. The successful bidder is required to enter into a contract agreement on a non-judicial stamp paper of Rs.200/- (Rupees Two hundred only) with usual terms and conditions.
3. The quantity mentioned is approximate and may vary depending upon the requirement. The Tendered quantity may be increased or decreased by 25%, without any change in unit price quoted.
4. The duration of the rate contract is for a period of **12 months** from the date of agreement and it can be extendable for a further period of 3 (three) months.
5. The payment will be released within 15 days after satisfactory supply to our Corporate Office and on submission of bill. No advance payment will be made. Applicable taxes, if any, will be recovered from the bills.
6. **Delivery:** The successful bidder is expected to supply within 15 days from the date of issue of Purchase Order. The Successful bidder should supply the Computer Consumables – Compatible/Equivalent Cartridges for EPSON DLQ 3500 printers Free On Road/Rail to Corporate Office, as and when the orders are placed for supply by the Corporation, during the contract period.
7. The Corporation is at liberty to levy penalty of a maximum of 10% of the ordered value in case of failure to deliver the Cartridges for EPSON DLQ 3500 printers within the stipulated period. The Corporation reserves the right to cancel the order, in case the supplier delays the supply for more than seven days from the date specified and agreed therein and also to forfeit the EMD/Security Deposit. For any loss arising out of delay in supply or non-conforming to the specifications/quality etc., will be to the account of the supplier.

8. The Earnest Money Deposit amount of Rs.20000/-[Rupees Twenty thousand only] by way of demand draft drawn in favour of KSBCL on any nationalized bank and should be submitted alongwith bids. The bids without EMD will be rejected.
9. The EMD of unsuccessful bidders will be released immediately after placing order with the successful bidder. The EMD furnished by the successful bidder will be converted as security deposit towards performance security and the same will be released after successful completion of the contract.
10. The EMD/SD will be forfeited in the following cases:
  - i. If the successful Bidder fails to accept the order based on their offer and / or fails to enter into a Contract Agreement within 15 days from the date of acceptance of the quotes/ tenders by the Corporation.
  - ii. If the successful Bidder delays day to day services beyond 7 days time resulting in disruption of the Corporation works.
